I. Call to Order and Roll Call

II. Approval of Agenda

Vice President Judas moved, and Director St. John seconded the motion to approve the agenda as posted. Motion passed with all ayes 6-0.

III. Communication from the Public

John Hollebrands, 4217 86th Street, mentioned that the Board of Directors' agenda for their meeting that night had not been posted to the website.

IV. Good News

Dr. Stilwell presented DIBBELS data showing student achievement increases.

V. Consent Agenda Items

- A. Approval of the Open Enrollment report, including one student into the District, and two enrolling out for the 2012-2013 school year; and for two students open enrolling into the District and no students out of the district for the 2013-2014 school year;

- D. Approval of the Out of State Travel request for the instrumental music students to Minneapolis, MN for the Vocal Music and Cultural Enrichment and Competition on March 14 17, 2013;

A. Approval of Guiding Principles Page of District Strategic Plan

Director Farrell moved, and Director Wierson seconded the motion to approve the proposed Guiding Principles Mission, Vision, and Values sections, with the option for the Vision for Learning and System Goals sections to be brought to a future meeting for the Board's consideration. B. Discussion and Approval of a Fixed Asset Inventory and Valuation Services Project with Enterprise Asset Services, Inc.

Shelly Clifford, Chief Financial Officer, discussed the need for an accurate valuation of the District's assets for insurance and accounting purposes. Ms. Clifford recommended approval of the agreement with Enterprise Asset Services, Inc. to perform the services discussed. Vice President Judas moved, and Director St. John seconded the motion to approve the agreement with Asset Services, Inc. for Physical Inventory and Valuation services. Motion passed with all ayes 6-0.
