

The Urbandale Community School District has been allocated \$2,193,764 in the 3rd round of Elementary and Secondary Emergency School Relief (ESSER) funding. Of these funds, 20%, or \$438,753 must be reserved to address learning loss (summer school or other remediation).

The balance, \$1,755,011 may be spent on ESSER allowable expenses, including activities necessary to maintain the operation of and continuity of services in the local educational agencies and continuing to employ existing staff of the local educational agency.
