#### **Description:**

#### **Experiences in Literature and Writing 2**

Experiences in Literature and Writing 2 provides students with a variety of reading and writing using fiction. Readings and writings may include: writing reflections, narrative writing, real world writing, journaling, analyzing literature, short stories, etc.

#### Life Long Learner I

The Life Long Learner I course provides students a study of a wide selection of fictional reading with an additional focus on visual literacy (Readings may include painting, photographs, and graphic novels.) Students also learn forms of writing in the working world (Writings may include blogging and journaling).
